RECOGNITION ORDER

- 8. The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

 - Facilities added during the last quarter
 - Number of books in the library journals subscribed to and additions, if any, in the last quarter
 - The affidavit with enclosure submitted along with application. j)
 - The institution shall be free to post additional relevant information, if it k)
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
